#### **CITY MANAGER'S REPORT**

#### June 1, 2021

- The Street Crew continues prepping for the slurry sealing earlier than normal. Please keep them in mind as you travel the city in the next few weeks.
- Next Monday we begin the annual flushing of the fire hydrants. This usually disturbs the pipes and causes the water to be momentarily color-stained. PLEASE watch for updates and/or the firemen are working in your area, shut off your ice makers and once the firemen have left, flush out your water pipes.
- The Streetscape project is substantially completed. Staff and McClellan engineers met with the contractor today and will be finalizing a punch list for completion. The light post on the north end of the block has been ordered but will not be here for another 90-120 days. We'll close out the grant once those are installed.
- Thank you to those who were able to attend the Corporate Hanger #3 ribbon cutting on May 26<sup>th</sup>. It was great to have the Dept of Aeronautics Director Jerry Chism here for the event. We look forward to the next ribbon cutting!
- The Police Dept is accepting applications to fill 2 vacancies. Applications may be picked up at the Police Station and must be completed and turned in by June 25<sup>th</sup>.
- Aquatic Park Update The pool play structure has been manufactured and is being shipped this week. The contractor is staging equipment now and will begin work as soon as the structure arrives. They are pressing hard for the 29<sup>th</sup> but it will be tight.

The staff has been hired and are working on task training.

The concessions orders will be in place

Awning people have taken down 2 awing that will be replaced this year. We replaced 6 of the awnings last year.

Upon completion of the installation, we'll fill the pool and then balance the chemicals so it will take a few days after installation to get everything ready for the Health Dept inspection.

• In our Dept. Head meeting last Friday Junior Rodemeyer gave his report. There was so much going on I had him send it to me for inclusion in your Information Only as there is too much to discuss here. The staff continues to push for interest and participation and it appears from the sign-ups, we are making headway.

Re: Vacate/Abandon 9th Street, North of Hickory Street

Ouachita Baptist University has requested to vacate N 9th Street, from Hickory Street north to the end of 9th Street to accommodate proposed student apartments.

Information to vacate a street or alley was sent to Mr. Keldon Henley of Ouachita Baptist University. He requested Hughes and Hughes Law Firm to handle the filing of the petition.

Eric and Erica Hughes, of Hughes and Hughes Law Firm, filed the petition with the City Clerk to vacate the street on behalf of OBU, whom owns all the properties North of Hickory Street abutting 9th Street.

A legal notice was published in the Arkansas Democrat-Gazette on June 6, 2021 and will be on June 13<sup>th</sup>. No Citizens have objected to the request to vacate the street.

#### Steps to vacate a street:

- 1. Petition filed with the City Clerk
- 2. Resolution by the City Board of Directors to set a public hearing for next meeting
- 3. City Clerk to give notice of the meeting by publication in the newspaper once a week for two consecutive weeks prior to the scheduled public hearing. Notice shall include:
  - a) Names of persons who signed the petition
  - b) Name of street or portion thereof, to be vacated. If not named on the plat, identification shall be by the abutting lot or block numbers (legal description)
  - c) Date, time and location of public hearing
  - d) Any property owner affected by the petition shall be heard.

4. Written Consent of all property owners/utilities

a) Petitioners must file with the City Clerk, prior to the public hearing, written consent or signatures on the petition of all property owners abutting the street or alley to be vacated (State Code). Consent from all utility providers (water, electric, gas, telephone, and cable/satellite must also be obtained (City requirement).

#### 5. Public Hearing

- a) Any property owner affected by the petition shall be heard.
- b) Board shall consider public interest and welfare in consideration of street to be vacated.
- c) No street shall be vacated unless written consent of the owners of all lots abutting on the street to be vacated has been filed with the City Board of Directors

## 6. Ordinance to Vacate

- a) Granting of the petition shall be by majority vote and incorporated into an ordinance.
- b) Ordinance shall have three readings
- c) Ordinance shall be published in a newspaper of general circulation.

1.

Ouachita owns land within the City of Arkadelphia, a City of the First Class.

11.

A portion of the lands owned by Ouachita are bisected by a street designated as 9th Street, within the Hardy & Barkman's Addition to the City of Arkadelphia, a plat of which is attached as Exhibit 1.

III.

The city council of the City of Arkadelphia has jurisdiction to consider a petition to vacate street pursuant to Ark. Code. Ann. § 14-301-301 et seq.

IV.

Ouachita owns the properties described in Exhibit 2, attached hereto and incorporated by this reference.

٧.

The deeds whereby Ouachita acquired the property are attached as Exhibit 3.

VI.

9<sup>th</sup> Street bisects the property of Ouachita north of Hickory Street and dead ends at property owned by Ouachita. Ouachita owns the property on both sides of 9<sup>th</sup> Street, and there are no other landowners to give written consent.

VII.

That portion of 9th Street described above is not needed for a public street since all adjoining property north of Hickory Street is owned by Ouachita, an educational institution.

VIII.

The City Council should adopt an ordinance vacating that portion of 9<sup>th</sup> Street north of Hickory Street.

WHEREFORE, PREMISES CONSIDERED, Petitioner prays that the City Council adopt an ordinance vacating those portions of 9<sup>th</sup> Street, described above and further prays for any and all other relief to which it may be entitled.

Requested by Ouachita Baptist University

Following the conclusion of the Public Hearing regarding the vacating of a portion of N. 9<sup>th</sup> Street, you will need to pass an ordinance to vacate the requested area.

Attached for your perusal, please find the Ordinance to allow for the vacating of a portion of N. 9<sup>th</sup> Street for future development.

As both sides of the dead-end street are owned by OBU and it is the natural order of progression for OBU to develop the western border of their campus, staff supports the request.

The caveat to the ordinance will be utilities easements. Section 2 requires OBU to pay for any utility relocation if required.

Staff recommends placing the ordinance on its first reading, less the legal descriptions.

This is exactly what you did Ordinance NO O-19-09 for a portion of 7th Street vacating in October 2019.

#### **ORDINANCE NO. 0-21-**

# AN ORDINANCE TO VACATE A PORTION OF A STREET LOCATED AT 9<sup>TH</sup> STREET NORTH OF HICKORY STREET IN THE HARDY & BARKMAN'S ADDITION.

**WHEREAS**, A Petition was filed with the Board of Directors of the City of Arkadelphia, Arkansas on May 26, 2021 to vacate and abandon a portion of North 9<sup>th</sup> Street designated on the lots and block of the Hardy & Barkman's Addition to the City of Arkadelphia and;

WHEREAS, after due notice as required by law, the council has, at the time and place mentioned in the notice, heard all persons desiring to be heard on the question and has ascertained that the easement of the portion thereof, herein before described, as heretofore been dedicated to the public, use as an easement herein described; that the owners of the property abutting upon the portion of North 9<sup>th</sup> Street to be vacated have filed with the Board of Directors their written consent to abandonment; and that public interest and welfare will not be adversely affected by the abandonment of the portion of North 9<sup>th</sup> Street.

# NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE CITY OF ARKADELPHIA, ARKANSAS:

**SECTION 1:** The City of Arkadelphia, Arkansas releases, vacates, and abandons all its rights, together with the rights of the public generally, in and to the portion of North 9<sup>th</sup> Street designated as follows:

308 N 9th Street- A part of Lot 3 in Hardy & Barkman's Addition to the City of Arkadelphia, Clark County, Arkansas, according to the Plat thereof, recorded in Book G at Pages 422-423 of the Deed Records of Clark County, Arkansas, particularly described as commencing at the SE Corner of said Lot 3 and running thence West 100 feet; thence North 75 feet to the Point of Beginning, thence run North 60 feet; thence West 100 feet; thence South 60 feet; thence East 100 feet back to the Point of Beginning.

312 N. 9th Street- Commence at the SE Corner of Lot 3 of Hardy and Barkman's Survey Addition to the City of Arkadelphia, Clark County, Arkansas and run thence West 100 feet, thence North 135 feet to the Point of Beginning, thence run West 100 feet; thence North 50 feet; thence East 100 feet; thence South 50 feet to the Point of Beginning, being a plot of ground 50 feet North and South by 100 feet East and West.
